

In accordance with section 221B of the *Electoral Act 1992 (ACT)* I am writing to advise you that you may be required to submit a donors annual return to the Australian Capital Territory (ACT) Electoral Commission.


During the period 1st July 2007 to 30th June 2008, according to our records, you made contribution(s) of \$1,500 or greater to the Liberal Party of Australia (ACT Division). According to our records, over the period you have made gifts to the party to the total value of \$1800.

The Act requires that persons who make gifts that are equal to or greater than \$1,500 must submit a return to the ACT Electoral Commission. The term 'gift' is specifically defined in the Act.
