Report on the 2017 ACT Aboriginal and Torres Strait Islander Elected Body election

Enclosed is the report on the 2017 election of members to the Aboriginal and Torres Strait Islander Elected Body. This report is prepared in accordance with section 189A of the *Electoral Act 1992* (the Electoral Act) as applied by the *Aboriginal and Torres Strait Islander Elected Body Act 2008* (the ATSIEB Act).

Section 189A provides:

189A Report of result of ATSIEB election

- (1) As soon as practicable after the result of an ATSIEB election has been decided, the commissioner must give the ATSIEB chair (or, if there is no chair, the Minister) a written report setting out:
 - (a) the election results; and
 - (b) the number of votes received by each candidate.
- (2) The commissioner must make the report available to the public during ordinary office hours.

This election report is available for public inspection at the office of the Electoral Commissioner. A copy of this report has also been published on the Elections ACT website www.elections.act.gov.au.

Introduction

This report on the 2017 election of members of the Aboriginal and Torres Strait Islander Elected Body is prepared in accordance with section 189A of the *Electoral Act 1992* (the Electoral Act) as applied by the *Aboriginal and Torres Strait Islander Elected Body Act 2008* (the ATSIEB Act).

This election report is available for public inspection at the office of the Electoral Commissioner. A copy of this report has also been published on the Elections ACT website www.elections.act.gov.au.

An election for the Aboriginal and Torres Strait Islander Elected Body under the ATSIEB Act commenced on 15 May 2017 and concluded on 20 July 2017.

The formal declaration of the results of the election is set out in notifiable instrument NI2017-394. A copy of the instrument is at **Appendix A**. This instrument was notified on 20 July 2017 and took effect on 21 July 2017.

The number of votes received by each candidate as first preferences, and the further distribution of preferences to determine the results of the election, are set out at **Appendix B**.

Overview of the election

The ATSIEB Act provides for elections for the Elected Body to be conducted by the ACT Electoral Commissioner.

Seven members are elected to represent members of the ACT Aboriginal and Torres Strait Islander community on the Elected Body.

To be eligible to vote in an election or to stand as a candidate a person must be:

- an Aboriginal person or Torres Strait Islander;
- at least 18 years of age; and
- on, or eligible to be on, the ACT electoral roll.

In addition, candidates must not be under sentence of imprisonment for 1 year or longer for a conviction for an indictable offence.

Eligible electors could vote by attendance at a polling place or by post.

The voting and counting system used for the election is the Hare-Clark electoral system as set out in the Electoral Act. This is the same system used for ACT Legislative Assembly elections, with some modification to suit the circumstances.

Nominations

The nomination period opened on the election start day – Monday 15 May 2017. The nomination period closed at noon on Monday 29 May 2017.

Candidates needed to be nominated by at least 4 persons eligible to vote in the election.

Nominations were received from 25 candidates. This was the most nominations received for any Aboriginal and Torres Strait Islander Elected Body election to date. The names of the candidates were publicly declared by the Acting Electoral Commissioner at the Aboriginal and Torres Strait Islander Cultural Centre, Yarramundi Reach, Yarralumla, at noon on Tuesday 30 May 2017.

Draw for positions

The draw for positions on the ballot paper was conducted in public by the Acting Electoral Commissioner immediately after nominations were declared. This was achieved using the double randomisation draw method. A copy of the ballot paper is at **Appendix C**.

Information campaign

Elections ACT, on advice from and in consultation with OATSIA, took reasonable steps to inform potential electors and potential candidates of the 2017 ATSIEB election. The campaign communicated several messages to electors, including:

- Eligibility requirements to nominate as a candidate;
- Eligibility requirements to vote in the election;
- Relevant dates for the election;
- Locations of polling places; and
- Any further relevant information relating to the ATSIEB election.

The information campaign included the following methods for engaging the community:

- Media releases – in conjunction with significant milestones in the progress of the election process;
- Access Canberra silver screens;
- Newspaper advertisements placed in the Canberra Times and Chronicle;
- Elections ACT website;
- Facebook;
- Twitter;
- Whole of government messaging;
- Digital postcards;
- Information brochures/flyers;
- Posters;
- Public events including, community briefing, RAP expo, NAIDOC family day, Boomanulla Raiders football match, Canberra Raiders football match.
- Meet the candidate sessions organised and facilitated by OATSIA (with an ACT Electoral Commission presence) including a session at the Alexander Maconochie Centre.
- Message dissemination via the Indigenous yahoo network – coordinated by OATSIA.

The Commission worked closely with graphic designers from Octavo Designs and ACT Publishing Services to prepare the printed advertising materials and silver screen advertising. A new colour scheme was used for 2017 advertising with the key message “Make Your Voice Count” retained from previous elections. Elections ACT undertook placement of the newspapers advertisements through the ACT Government media service provider Dentsu Mitchell.

Elections ACT recommends continuing to conduct polling at NAIDOC specific community events and to continue to attend community events in the lead up to an Aboriginal and Torres Strait Islander Elected Body election. For the 2020 election, it is the view of the Commission that work could commence through attendance at appropriate community events and the dissemination of information as early as January 2020. This would bring forward the commencement of activity from May.

Polling

Staffing

The following positions were filled to assist with the conduct of polling at 24 locations over 8 days of polling:

- 3 Officers in Charge (OIC);
- 3 issuing officers;
- 14 liaison officers (who were also issuing officers), appointed in consultation with the Aboriginal and Torres Strait Islander Elected Body:

Of the 14 liaison officers:

- 8 were employees from the Office for Aboriginal and Torres Strait Islander Affairs;
- 2 were existing ACT Government employees from other agencies, released by their directorates specifically to work on this election;
- 4 were new employees engaged to work on this election.

The Electoral Commission recommends continuing to seek existing ACT Government Aboriginal and Torres Strait Islander employees to work as liaison officers on the election. As in 2016 this will require continued approval from the ACT Government Head of Service.

All staff from the ACT Electoral Commission were appointed as issuing officers for the 8 days of polling so votes could be issued at the office of Elections ACT. Two staff from Elections ACT also assisted with the conduct of polling at a number of offsite polling locations including the NAIDOC ball, NAIDOC family and community day, the Namadgi school dance, AMC, and the NAIDOC on the lake event.

The liaison officers' role was to ensure that only eligible Aboriginal persons or Torres Strait Islanders voted in this election. If the liaison officer determined, on the balance of probabilities, that an elector was not eligible to vote, the liaison officer could formally challenge the voter's eligibility.

Two challenges were issued by a liaison officer over the course of the 2017 polling period. These challenges were referred to the review panel to determine if the eligibility of the elector and whether the ballot should be admitted to the count. See page 10 for the review panel's decision.

For the 2020 election, the Electoral Commission recommends identifying more NAIDOC specific community events at which to hold polling and reducing or removing polling at some office based locations such as Gungahlin, Dickson and Barton.

Voting at the Alexander Maconochie Centre

Arrangements for polling at the Alexander Maconochie Centre (AMC) were made through the Justice and Community Safety Directorate (JACSD) and the Office for Aboriginal and Torres Strait Islander Affairs (OATSIA). The 2017 election was the second time that polling had been offered inside the prison for the Aboriginal and Torres Strait Islander Elected Body election.

A 'meet the candidates' day was organised and hosted inside the AMC on Tuesday 27 June 2017. Approximately 25 male detainees attended the men's morning session and approximately 10 women attended the afternoon female session.

Candidates were each given 2 minutes to talk. Elections ACT also gave a short overview of the election and the process of voting.

According to JACSD, at the time of polling at the AMC on Wednesday 5 July 2017, approximately 91 detainees identified as being an Aboriginal person or Torres Strait Islander. Of the 91 potential electors, a total of 61 people cast a vote. These were made up of 17 ordinary votes and 44 declaration votes. Following a preliminary scrutiny, 41 declaration votes were admitted to the scrutiny and 3 were rejected.

Votes issued

Ordinary votes were issued to those voters whose names were found on the certified list of electors for the election and whose eligibility was not challenged by a liaison officer. If a name could not be found on the certified list, or eligibility was challenged, a declaration vote was issued. 'Not on roll' declaration voters were asked to provide proof of ACT residence and where provided was noted on the declaration envelope. If the voter did not provide proof of residence at the polling place they were informed that they had until Wednesday 12 July 2017 to provide proof of residence to the Electoral Commissioner. Of the 102 declaration voters, 82 were able to provide proof of residence. These votes were admitted to the count.

Postal voting

Electors who were unable to attend a polling place were eligible to apply for a postal vote for the election. A total of 24 applications for postal votes were received and processed.

A total of 9 postal vote certificate envelopes containing ballot papers were returned to Elections ACT. 7 were admitted to the count. 2 postal votes were rejected and not admitted to the count.

Review panel

A 3 person review panel was appointed in consultation with the Aboriginal and Torres Strait Islander Elected Body to review the eligibility of:

- any voters challenged by the liaison officer; and
- all postal voters.

The review panel met on Wednesday 12 July 2017. Of the 7 postal votes received by this time, the review panel accepted all 7 postal votes, as on the basis of the available evidence, the review panel was satisfied the voter was eligible to vote in the election.

The final 2 postal votes were not provided to the review panel for eligibility assessment as they did not pass the initial stage of the preliminary scrutiny as they had not been completed and signed on or before the close of polling – Saturday 8 July 2017.

The review panel also reviewed two eligibility challenges issued by a liaison officer at separate polling places. The review panel unanimously decided, on the balance of probabilities, the following:

1. Challenge issued on Wednesday 5 July 2017 - the voter was not an Aboriginal person or Torres Strait Islander. The ballot was rejected.
2. Challenge issued on Thursday 6 July 2017 – the voter is an Aboriginal person or Torres Strait Islander. The ballot was admitted to the count.

As required under the Act, the Electoral Commissioner wrote to both electors to inform them of the review panel's decision.

Scrutiny

The scrutiny for the election was conducted using the Hare-Clark electoral system, in the Theatrette of the Canberra Museum and Gallery, commencing at 10 am on Wednesday 19 July 2017. Elections ACT staff conducted the scrutiny. Two scrutineers were appointed by two candidates and were present throughout. The scrutiny was also observed by staff from the OATSIA Office.

Two election officials and a scrutineer verified that seals on the ballot boxes were intact before the seals were removed.

At the preliminary scrutiny of the 102 declaration votes, 19 declaration votes were rejected as the voters were not on the electoral roll and did not provide proof of ACT residency. A further declaration vote was rejected by the review panel, upholding the liaison officer's eligibility challenge. At the preliminary scrutiny of the 9 postal votes, 7 were admitted to the count and 2 were rejected.

A total of 111 declaration votes (including 9 postal votes) were issued and 89 were admitted to the count.

A total of 346 ordinary votes were admitted to the count.

At the beginning of the scrutiny, after combining ordinary votes (346) and declaration votes (89), a total of 435 votes were admitted to the count. 3 ballot papers were deemed informal. With 432 formal votes in the count the quota for election was 55.

The scrutiny was completed by 2:30 pm on Wednesday 20 July 2017.

The Acting Electoral Commissioner officially declared the poll at 12 noon on Thursday 20 July 2017 at the Theatrette at the Canberra Museum and Gallery. Full scrutiny sheets were made available at the public declaration and a copy is attached at **Appendix B**.
